#### THE FUTURE OF THE DAWS HILL NEIGHBOURHOOD FORUM?



Since its formal Constitution on 10<sup>th</sup> September 2012, the Daws Hill Neighbourhood Forum (DHNF) has represented the interests of residents of "our" neighbourhood area. Notable achievements have included.

- Protection of the character of the area e.g. influencing a reduction in the housing density of the Pine Trees development, including forcing a Judicial Review
- Getting Bucks County Council to reconsider its Daws Hill Area Public Transport bus link
- Ongoing vetting of local planning applications that have prevented developments such as inappropriate telephone masts and out of character extensions.

However, since 2012 the population of our area has changed – with a number of previous residents departing and new ones moving in. This has resulted in a reduced number of current active DHNF committee members and a reduction in the accuracy of our residents' database.

• As a result - and being blunt - both these aspects need to be addressed if the Forum is to continue.
